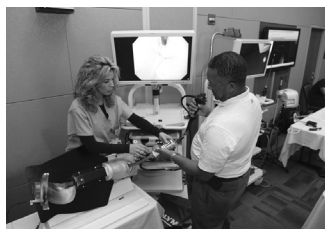

The 53rd Clinical Congress held Oct. 31st–Nov. 2nd, 2014 in Tampa, Florida was jam-packed from beginning to end with state-of-the-art equipment, task training and cutting-edge lectures, along with evenings full of fun for the families of our attendees.



Friday's session was held at the Pepin Heart & Research Institute – Florida Hospital and consisted of live-stream and interactive surgeries in the morning while the afternoon session consisted of hands-on, instructional task training stations including:



DaVinci Robotic Simulation & Dual Console; Transoral Incisionless Fundoplication; Stretta – Endoscopic Procedure for GERDS; Laparoscopic Training of Cholecystectomies with live specimens and Hepatic Energy Application – Porcine Model.

Saturday's session was held at Embassy Suites Downtown Convention Center–Tampa Bay and included lectures on Advances in the Treatment of Acid Reflux; Radiofrequency Ablation vs.

Endoscopic Surveillance for Patients with Barrett Esophagus & Low Grade Dysplasia; Advances in Pancreatic Cancer; Regionalization of Healthcare; Update in Foregut & HPB Surgery Innovations; Should I Add Robotic Surgery to My Practice?; Genetic Changes Associated with Foregut & HPB Cancers; Parathyroid Disease: Past, Present & Future and Palliative Care in the Age of Healthcare Reform.



At the adjournment of the Saturday afternoon session, medical staff and their guests were invited to attend our complimentary “Little Italy – Italian Gala” at the hotel for a delightful evening of socializing, meeting new friends and of course eating soup to nuts and everything in between.

Sunday morning's session continued with a highly spirited and interactive exchange on Healthcare Reform: The Good, The Bad and The Ugly and concluded with a lecture on Hyperbaric Oxygen Therapy – Past, Present and Future.
